Payment Plans: Tuition may be paid annually or monthly. However, two week's tuition and registration fee needs to accompany this contract. Annual payments made by September 15, will receive a 5% discount on tuition. All payments are due by the 1st of each month. A \$20.00 late fee will be assessed to payments after the 15th of each month. There is a tuition discount of \$90.00 per year per child for two or more children of the same parent. A \$20.00 fee will be assessed for any return checks. The most important years of growth are the first six years of life when unconscious learning is gradually brought to the conscious level.

It is understood that this contract may be cancelled if the school is notified prior to August 1 and that the school will refund any prepaid tuition in full within 30 days of receipt of cancellation notice. If written notice of cancellation is made after August 1, one fifth of two week's tuition amount will be deducted from refund for each week of part thereof after August 1. To cancel this contract after the school term has begun, 14 days written notice is required and any prepaid tuition remaining on the account beyond that 14 days will be returned to you. The school reserves the right to discharge a student for any reason whatsoever at any time, and in such event shall refund any prepaid tuition in full. The school will exercise such discretion only in the event it deems such action necessary in the best interest of the child or in the best interest of the other students.

I understand that there is no automatic reduction of fees when my child is on vacation or gone from Casa Montessori Preschool for any other reason.

I understand that if there is a global pandemic that is out of Casa Montessori's hands, tuition will still be expected to be paid monthly, unless otherwise stated by Casa Montessori.

I understand there is a returned check fee of \$20.00.

Two weeks advance written notice to Casa Montessori Preschool is required when withdrawing a child from Casa Montessori Preschool. If two weeks advance notice is not given, any prepaid tuition past two weeks will not be refunded.
